Resolution (Argumentation)	<ul> <li>None; not responsive to original dilemma.</li> <li>Proposed resolution lacks integrity; dishonest.</li> </ul>	<ul> <li>Only applies or cites rules with little or no justification; may be using rules out of context.</li> <li>Only states possible resolution(s)</li> <li>Only infers consequences</li> </ul>	<ul> <li>Limited ability to use facts to differentiate among alternatives.</li> <li>Proposed resolution is feasible</li> <li>Recognizes recommendation has consequences.</li> </ul>	<ul> <li>Proposes several alternatives and considers consequences of each.</li> <li>Considers potential of risk to public and/or safety.</li> <li>Incomplete win-win solution suggested.</li> </ul>	<ul> <li>Resolves case through clear argumentation and consideration of all primary stakeholders.</li> <li>Understands consequences of various actions.</li> <li>Proposes creative middle ground (win-win situation) solution.</li> </ul>
